## Municipal Supports

### [Business Advisory Services](#)

Free 1-hour consultation with a Legal, Accounting, Business Operations, Sales and Digital Marketing Strategies professional, including guidance on COVID-19 support programs (support available in multiple languages).

### [#MississaugaMade](#)

The Mississauga Made marketplace is a FREE promotional advertising opportunity for all locally-based businesses.

### [2021 Property Tax Deferral Program](#)

Residential and commercial property owners impacted by COVID-19 may apply for a deferral of 2021 property tax payments until December 15, 2021.

## Provincial Supports

### [Ontario Small Business Support Grant](#)

Provides a \$10,000 to \$20,000 grant for small businesses required to significantly restrict or close operations due to public health measures or small businesses within the tourism and hospitality sector.

### [Ontario Property Tax & Energy Cost Rebate](#)

Provides property tax and energy bill rebates for businesses required to significantly restrict or close operations due to public health measures.

### [Ontario Main Street Relief Grant](#)

Provides a grant of up to \$1,000 to help small businesses (2 to 19 employees) cover costs related to personal protective equipment (PPE).

Businesses who have questions about how public health measures impact their business, including capacity limits, can call 1-888-444-3659.

## Federal Supports

### [Canada Emergency Wage Subsidy](#)

Provides a subsidy of up to 75% for eligible wages.

### [Canada Emergency Rent Subsidy](#)

Provides a subsidy of up to 65% for property-related expenses such as rent, mortgage interest, property tax and insurance payments (plus an additional 25% for businesses impacted by lockdown restrictions).

### [Canada Emergency Business Account](#)

Provides an interest-free loan of \$60,000 for small businesses. If repaid by December 31, 2022, \$20,000 of loan will be forgiven.

## Digital Technology Supports

### [Digital Service Squad](#)

Digital experts will provide free one-on-one assistance to build online promotion strategies.

### [ShopHERE](#)

Provides independent businesses and artists with resources to develop and launch an online store for free.

### [DMS Future Proof](#)

Free digital transformation plan with support from a team of marketers, web designers and creators over a 6 week period.
